PARTICIPATION RULES

- Submission of an entry form by May 31 2023 via www.danceit.pl or via e-mail at studio@bailamos.pl
- The number of spots is limited, the order of applications is decisive.
- We reserve the possibility of not accepting an application in case of too many entries.
- The tournament is held according to WADF rules for all dancers regardless of federation affiliation and no dancer-competitor licence is required.
- A club licence in the WADF federation is obligatory (50 EUR)

- Solo, duos, couples performed to the music provided by the host other presentations to the participants' own music.
- Payment of the entry fee in the amount of:
 - 1 entry - 40 PLN
 - 2 entries - 80 PLN
 - 3 entries - 120 PLN
 - 4 entries - 160 PLN
 - 5 entries - 200 PLN
 - 6-9 entries - 240 PLN
 - 10 entries and more - 280 PLN
- The same contestant or team is allowed to compete in several dance categories.
- The entry fee with a detailed description should be paid into bank account by June 10 at the latest, **after June 10 the fee increases by 10%.**

INFORMATION

- Once the entry lists are closed, a detailed itinerary will be announced (June 7 at the latest).
- Spectators' tickets are available at a cost of PLN 40 per day (children under 7y.o. free of charge).
- Each participant of school age should have a school ID card.
- Insurance costs are to be covered by the participant.
- The team should have an appropriate number of chaperones in accordance with the current regulations and comply with the general regulations of safety, health and fire protection.
- The guardian of the team shall bear full responsibility for the safety of the participants.
- The organizer reserves the right to combine categories in the event of a low number of entries.
- The organizer does not insure the contestants taking part in the tournament and is not responsible for items left in the locker room and the arena.
- Participants come at their own expense or at the expense of the delegating institution.
- During the tournament, the organizer provides a professional sound system, a 20m x 15m dance floor and medical care.
- It is forbidden to use scenery elements, props or costumes that could permanently damage or stain the dance floor.

DANCE FESTIVAL

- Spilling, spreading and scattering of any substances and small items is forbidden and all props, scenery and costume elements brought by dancers to the stage must be cleaned up from the stage within 30 seconds following the performance.
- Disputes shall be settled by the Tournament Executive.
- The submission of an application and participation in the festival on June 18, 2023 is equivalent to free permission for photographic, video and television recording of all performances and their use, publication and broadcast in any media by the hosts, the use of personal data (name and surname) and image of participants in festival materials (entry lists, lists of laureates, etc.), participation in recordings of the festival broadcast in social media.
- Entry to the festival implies acceptance of all the provisions of these regulations.

AWARDS

- All the contestants will receive diplomas for participation.
- Laureates will receive a diploma and a medal.

JUDGES COMMITTEE

- Dancers are judged by WADF licensed judges and VIP judges and in accordance with WADF regulations.
- Decisions of the Jury are irrevocable and final, in matters of dispute the chairman of the committee has the casting vote.

PERSONAL DATA

- The Administrator of the personal data collected and processed in the course of the Fale Loki Koki Dance Festival is Bailamos Dance Studio 28 Konopnickiej ST in Bydgoszcz.
- Providing personal data is voluntary and the data will be processed for the purposes of carrying out the Festival.
- The legal basis for the processing of personal data is their necessity for the fulfillment of the obligation to execute the festivals - (Article 6(1) (C) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), in force from 25.05.2018. (hereafter "GDPR")
- The personal data provided will be processed for the duration of the Festival and the period of investigation of possible claims, as well as the period of making public law settlements under the applicable regulations and for archival purposes - the results of the competition.
- For the preparation and execution of the Festival, the Administrator may entrust the processing of personal data to entities cooperating in technical, promotional and organizational services.
- Individuals who have provided their data have the right to access the content of their personal data, the possibility to correct or rectify it, request the deletion of their personal data from the Administrator's collections, or limit its processing, if it is data not causing the impossibility of fulfilling the obligation to carry out the competitions - Article 6(1)(C) of the GDPR
- In the event that the processing of personal data by the Administrator is deemed to be incompatible with the applicable regulation, the person providing his/her personal data has the right to lodge a complaint with a supervisory authorities.
