The soloist's affiliation is determined by the date of birth, the duo's - the year of birth of the older dancer.

Participation rules

- *Submission of an enrollment by May 7, 2024 via worldartdance.com*
- **The number of participants is limited, the order of applications is decisive.**
- **The host reserve the right to reject the enrollment in case of too many applications.**
- The tournament is conducted according to WADF regulations for all dancers regardless of federation affiliation, active competitor's license is required (10 EUR) worldartdance.com/shop/competitor-licenses.
- It is mandatory to have active club/school membership license in the WADF (50 EUR) worldartdance.com/shop/club-and-school-membership-license
- Payment of an entry fee in the amount of:

1 entry – 20 EUR/90PLN	
2 entries – 30 EUR/135PLN	5 entries – 60 EUR/270PLN
3 entries – 40 EUR/180PLN	6 entries - 70 EUR/315PLN
4 entries – 50 EUR/225PLN	7 entries or more – 80 EUR/360PLN
- The same contestant or team are allowed to compete in several dance categories.
- The entry fee with a detailed description should be paid into the bank account by June 1st at the latest, after June 1st the fee increases by 10%:

Information:

THE JURY HAS THE RIGHT TO MOVE A DANCER ACCORDING TO HIS/HER SKILLS TO A LOWER OR HIGHER CLASS

- Once the entry lists are closed, a detailed itinerary will be announced.
- Audience entry tickets will be available on the day of the tournament, payment by card, cash, PLN only:

1-day ticket:

40PLN (normal - adult)
20PLN (discounted - student)

2-day ticket:

60PLN (normal - adult)
30PLN (discounted - student)

3-day ticket:

80PLN (normal - adult)
40PLN (discounted - student)

4-day ticket:

90PLN (normal - adult)
45PLN (discounted - student)

*entry for spectators up to age of 6 free of charge.

- Each participant of school age should have a school ID card.
- Insurance costs are to be covered by the participant.
- The team should have an appropriate number of chaperones in accordance with the current regulations and comply with the general regulations of safety, health and fire protection.
- The guardian of the team shall bear full responsibility for the safety of the participants.
- The organizer reserves the right to combine categories in the event of a low number of entries.
- The organizer does not insure the contestants taking part in the tournament and is not responsible for items left in the locker room and the arena.
- Participants come at their own expense or at the expense of the delegating institution.
- During the tournament, the organizer provides a professional sound system, a 20m x 15m dance floor and medical care.
- It is forbidden to use scenery elements, props or costumes that could permanently damage or stain the dance floor. Spilling, spreading and scattering of any substances and small items is forbidden and all props, scenery and costume elements brought by dancers to the stage must be cleaned up from the stage within 30 seconds following the performance.
- All the disputes are settled by the Tournament Supervisor.
- The submission of an application and participation in the festival is equivalent to free permission for photographic, video and television recording of all performances and their use, publication and broadcast in any media by the hosts, the use of personal data (name and surname) and image of participants in festival materials (entry lists, lists of laureates, etc.), participation in recordings of the festival broadcast in social media.
- Enrollment in the festival implies acceptance of all the provisions of its rules and regulations.

Judges Committee:

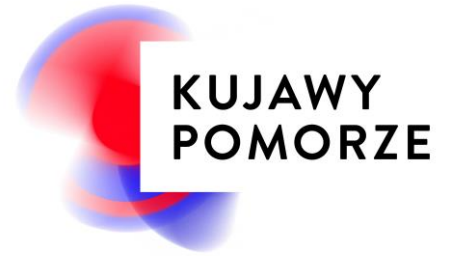
- Dancers are judged by WADF licensed judges and VIP judges and in accordance with WADF regulations.

Personal data:

- The Administrator of the personal data collected and processed in the course of the Fale Loki Koki Dance Festival is Bailamos Dance Studio, located at 28 Konopnickiej ST in Bydgoszcz.
- Providing personal data is voluntary and the data will be processed for the purposes of carrying out the Festival.
- The legal basis for the processing of personal data is their necessity for the fulfillment of the obligation to execute the festivals - (Article 6(1)(C) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), in force from 25.05.2018. (hereafter "GDPR")
- The personal data provided will be processed for the duration of the Festival and the period of investigation of possible claims, as well as the period of making public law settlements under the applicable regulations and for archival purposes - the results of the competition.
- For the preparation and execution of the Festival, the Administrator may entrust the processing of personal data to entities cooperating in technical, promotional and organizational services.
- Individuals who have provided their data have the right to access the content of their personal data, the possibility to correct or rectify it, request the deletion of their personal data from the Administrator's collections, or limit its processing, if it is data not causing the impossibility of fulfilling the obligation to carry out the competitions - Article 6(1)(C) of the GDPR.
- In the event of processing of personal data by the Administrator being deemed incompatible with the applicable regulation, the person providing their personal data has the right to lodge a complaint with a supervisory authorities.
