## Terms of participation:

- Submitting an entry form by the 11<sup>th</sup> of May 2025 via [www.worlddartdance.com](http://www.worlddartdance.com)
- The number of participants is limited, the order of application is decisive.
- We reserve the right not to accept entries in case of too many applications.
- The tournament is held according to WADF rules for all dancers regardless of federation affiliation, WADF competitor-dancer licence is required (€5) <https://worlddartdance.com/shop/>
- An active club licence in the WADF federation (for 2025) is obligatory (€25) <https://worlddartdance.com/shop/>
- Solo, duos, couples are performed to the organizer's music, other presentations to the participants' own music.
- Payment of the entry fee in the amount of:

1 entry- 20 EUR/90PLN

2 entries - 30 EUR/135PLN

- **In case of participation withdrawal later than May 30, 2025, the paid entry fee will NOT be refunded.**

## Particulars:

THE JURY HAS THE RIGHT TO REASSIGN A DANCER TO A LOWER OR HIGHER CLASS IN ACCORDANCE WITH THEIR SKILLS

- A detailed schedule will be released after the closing of the entry lists.
- Spectator tickets will be available on the day of the competition, payable by card or cash, PLN only:

**1-day ticket:**  
40PLN (regular - adult)  
20PLN (reduced - schoolchild, student)

45PLN (reduced - schoolchild, student)

\*entrance up to the age of 6 is free of charge.

- All participants of school age should have a school ID card.
- Insurance costs are covered by the participant.
- The team should have an appropriate number of chaperones in accordance with the regulations in force and should observe the general health, safety and fire protection regulations and sanitary regime procedures.
- The team's chaperone is fully responsible for the safety of the participants.
- The organizer reserves the right to combine categories in the event of a small number of entries and the right to change the number of dances presented.
- The organizer does not provide insurance the participants taking part in the tournament and is not responsible for any items left in the changing rooms and the halls.
- Participants arrive at their own expense or at the expense of the delegating institution.
- During the tournament the organizer will provide a professional sound system, a 20m x 15m dance floor and medical care.
- It is strictly forbidden to use scenery elements, props or costumes which could permanently damage or soil the dance floor. Spilling, pouring and scattering of any substances and small elements is forbidden and all props, elements of stage design and costumes brought on stage by dancers must be removed from the stage within 30 seconds from the end of the presentation.
- Disputes will be resolved by the Competition Supervisor.
- Submitting an application and participating in the festival on 5-8 June 2025 is equal to expressing one's free consent to photographic, video and TV recording of all presentations and their use, publication and broadcast in any media by the organisers, use of personal data (name and surname) and the image of the participants in festival materials (entry lists, lists of winners etc.), participation in recordings of the festival broadcast on social media.
- Registration for the festival implies acceptance of all the terms of these rules and regulations.

# Rules&Regulations

## Awards:

- All contestants will receive diplomas for their participation.
- Laureates will receive a diploma and a medal.

## Jury Committee:

- Dancers are judged by WADF licensed judges in accordance with the WADF regulations.
- The decisions of the Jury are irrevocable and final; in cases of dispute the chairman of the committee has the casting vote.

## Personal data:

- The administrator of the personal data collected and processed during the realization of the Fale Loki Koki Dance Festival is Bailamos Dance Studio at 28 M. Konopnicka Street in Bydgoszcz.
- The submission of personal data is voluntary, and the data will be processed for the purpose of Festival execution.
- The legal basis for the processing of personal data is their necessity for the fulfilment of the obligation to carry out the festivals - (Article 6(1)(C) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC, in force from 25.05.2018. (hereinafter: GDPR').
- The personal data provided will be processed for the duration of the Festival and the period for the assertion of possible claims, as well as the period for making public law settlements on the basis of the applicable legislation and for archival purposes - the results of the competition.
- For the purposes of preparation and implementation of the Festival, the Administrator may entrust the processing of personal data to entities cooperating in technical, promotional and organizational services.
- Persons who have provided their data have the right to access the content of their personal data, the possibility to correct or rectify it, to request the removal of their personal data from the Administrator's collection or to restrict the processing if it is data that does not make it impossible to fulfil the obligation to carry out the competition - Article 6(1)(C) of the GDPR.

# Rules&Regulations

- In case the processing of personal data by the Administrator is considered to be incompatible with the applicable regulation, the person providing their personal data has the right to lodge a complaint with the supervisory authority.
